

## Downtown Poplar Bluff Revitalization Grant Application

Downtown Poplar Bluff finds that the protection, enhancement and preservation of downtown structures are necessary to promote the economic, cultural and general welfare of the public.

The mission of this program is:

To stabilize and improve property values

To strengthen the economy of the City of Poplar Bluff by protecting and enhancing the attractiveness of the downtown district.

Provide support and stimulus to business

To encourage development and redevelopment in the downtown district.

In order to facilitate the preservation of downtown, Downtown Poplar Bluff is offering incentives that will improve existing properties and new and existing business within the downtown district.

All of the following eligibility criteria must be met:

- Eligible property must be within the downtown district.
- Applicants must agree to maintain the property in good repair for five years from the completion of the project.
- Property must be owner occupied or tenant occupied. In the case of a tenant occupied structure, the applicant must have the owner's consent. If leasing, the participant/applicant must:
- Have written approval for participation in the program from the property owner
- Have at least two years remaining on the lease
- Be in good legal and financial stading with the property owner. The participant/applicant must not have any major actual or pending criminal claims or bankruptcy filings
- All work must be completed in accordance with standard business and building standards and meet all City of Poplar Bluff permits and codes
- All taxes and other government fees and assessments must be current on the property
- Property cannot be subject to an Order for Demolition

Entities that are ineligible to receive funds include:

Taxing entities

The grant is set up as a single payment immediately upon approval

Grants will be awarded on a first come, first serve basis until funds are depleted

Applications will be reviewed and awarded by the Downtown Poplar Bluff Board of directors. There cannot be a conflict of interest between board members and grant recipients.

If at any time problems occur relating to the quality of work or work is not completed in accordance with the specification outlined in the application, then funds must be returned to Downtown Poplar Bluff.
