General Event Rules, Regulations and Specifications for Vendors

1. Payment **must** be included with application to reserve booth space(s). Booths will not be reserved without payment in full.
2. New vendors must submit photos of their booth/vendor trailer with their application.
3. All booth spaces are 10'x 20'. This space includes trailer tongues, axles, anchors and legs of canopies. If your measurement **exceeds** 10'x 20', please reserve an additional booth space. Please be prepared to anchor your canopy.
4. Tent, tables, electric, and direct water hookups are not provided.
5. All vendors must include a list of items to be sold with this application.
6. All applicants must include photos of your booth and items available for sale (providing a website is permitted). Applications without this will not be considered.
7. The event is an outdoor event on grass which may be uneven. The event will proceed, rain or shine. Vendors are responsible for their own booth's rain protection and are expected to secure their own booth(s). If weather becomes too severe, PBC will make the final determination. **NO REFUNDS** will be given for any reason.
8. PBC reserves the final and absolute right to interpret rules and regulations and to settle and determine all matters, questions or differences in regard thereto, or otherwise arising out of, connected with, or incidental to the event.
9. Vendors are responsible for collecting & reporting sales tax on all transactions.

Each vendor gets 2 tickets/armbands for Friday night.

Anyone extra must pay the \$5 admission fee.

Admission will be strictly enforced so please be prepared to show armband.

Banned Items

1. Dangerous, offensive or obscene materials including literature, t-shirts, shirts, hats, caps and flags or the like. "Obscene" is defined as vulgar or sexually explicit language including curse words, nudity, partial nudity, or the like.
2. Yard Sale/Flea Market items.
3. Snap pops or any other item containing explosive materials.
4. Knives, air guns, BB guns, pellet guns, etc.
5. The Poplar Bluff Chamber of Commerce (PBC) reserves the right to inspect your booth space for banned items. If present, PBC will ask you to remove banned items. If you choose not to comply, your booth will be closed, and you will be escorted from the festival immediately.

Trash Removal

Vendors **MUST** dispose of trash in the dumpsters provided during the event and prior to leaving the event. The lined trashcans that are placed around the festival are for event patrons and customers.

- Subleasing of all or any of the assigned booth space by the vendor is prohibited. Vendor cannot permit another party exhibit, promote, or take order in the booth for any services or items not described with this contract.

Contract: The Poplar Bluff Chamber of Commerce (PBC) reserves the right to terminate the vendor contract at any time and reserve the right to cancel any vendor during the event for non-compliance of festival rules. By submitting this signed form, the vendor waives PBC, and the City of Poplar Bluff, its officers, their agents, their assigns, their board and council members, their employees and event volunteers, sponsors and fellow participants from any liability due to personal injury, all risk of property (lost, stolen or damaged), as well as any bodily injury or death that might occur in connection to the event. PBC will not be responsible for accidents, damage, or theft during the event. Vendor must comply with any and all statutes and ordinances of the State, County, City and other governing authorities' rules and regulations which might apply, including but not limited to, rules and regulations affecting gambling, health & sanitation, building & electrical construction & maintenance, and fire safety. Any violation of these rules, regulations, statutes and/or ordinances shall result in immediate forfeiture of all rights of participation in the festival. Vendors may not sell raffle tickets or circulate petitions for signature without prior approval. No refunds will be given for inclement weather.
